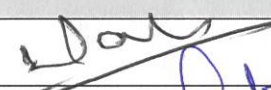
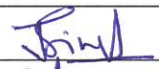
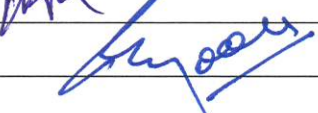
Please also note that only eligible GVC owners and voters of respective towers, will be able to participate in the elections for Tower Representatives (TR)

- c) **VOTERS:** As per Chapter IV and various sections and sub-sections, related to Elections, of the registered by-laws of Residents Welfare Association (RWA), Golf View Condos, Dwarka, New Delhi.

- i. **RWA Membership Registration:** Please also note that only those owners and/or co-owners, who are duly registered and approved members of Golf View Condos Resident Welfare Association (RWA), will be eligible to vote. The cut-off date and time for registration of candidates and voters, for RWA Elections 2026, is **on or before 8th July 2026 midnight 24:00 hrs Indian Standard Time (IST)**
- ii. **Voter Slips :** All eligible voters of GVC who become members of GVC RWA, on or before 8th July 2026, shall have to show proof of ownership-either "Possession Slip" or "Registered Sale Deed", along with any of the specified **Government Issued ID** in original (e.g. Aadhaar Card, Voter ID Card, Employee ID Card, Driving License, PAN Card, etc) Only then they will be eligible to cast their votes. This is required on the day of election. All eligible voters can collect a "Voter Slip" by showing any one of the above Government ID in original, from members of GVC Election Committee, from **12th July 2026 to 18th July 2026**. Exact time and venue of Voter Slip collection to be announced in due course.
