The GVC RWA Elections Committee 2026, fully understands, appreciates and respects the need to continue various types of social, cultural & religious activities involving GVC Community, especially during the intervening period of RWA Elections.

Meanwhile, all prospective candidates for RWA Office Bearers & Tower Representatives (TR) posts and the GVC voter community, are advised and requested to consider the following

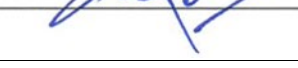
1. Adopt a non-partisan approach towards the candidates participating in the election, while organising any GVC community gathering by residents.
2. Not to use GVC community events, as a platform to deliver the election speech.
3. Last but not the least, as per **clause 4.12(l) of registered bye laws, candidates SHALL REFRAIN** from groupism, inducements, or defamatory campaigns. Proven violation during the election period may lead to rejection/cancellation of nomination or post-election removal after due process.

The RWA Elections Committee 2026 would like to appeal to the GVC Community, to promptly report such incidents or behaviours, which are prima facie violative of above aspects.
